Human Rights And What It Means To You

The Strategic Race and Equalities Forum meeting on Human Rights took place 4th March 2010 at the Civic Centre, Enfield. Funded by the Safer and Stronger Communities Board the meeting examined 'Human Rights and what it means to you.'

Vicky Dungate, EREC Vice Chair welcomed the 45 participants to the meeting, comprising of EREC members, council staff, school children and representatives from Black and Minority Ethnic groups. She then introduced the guest speaker, Joshua Castellino (Professor of Law & Head of Law Department, Middlesex University).

The Professor gave a fascinating talk on human rights including speaking about the European convention on human rights and the 1998 Human Rights Act before the participants broke into three interactive workshops to discuss and debate:

- Human rights legislation and how does it apply to me?
- How to make local policy and service providers accountable.
- Bringing together equalities bodies to work together to utilise the provisions of the human rights act to the benefit of their service users.

Each group produced action points from the above workshops and these will become the recommendations in the final report. This report will be disseminated to key strategic bodies and aims to influence change.

EREC Chair Meets the Prime Minister

Seventy local heroes from across the UK were present at a reception at 10 Downing Street hosted by the Prime Minister and his wife.

Mr Adeshina was invited by Labour MP, Andy Love for his work as Chief Executive and cofounder of O"-Bay Community Trust, a voluntary organisation in Enfield. He said he was "so surprised and pleased" for the PM to acknowledge the contribution he had made to the community.

The PM spoke about his appreciation of the Trust's activities as one of the organisations that works quietly behind the scenes,



yet impacts greatly on the welfare of people in the community. Mr Adeshina said "it was a great pleasure to meet the Prime Minister."

Young Migrants Research: 'No Right to Dream'

The Young Undocumented Migrants is a research project, commissioned by the Paul Hamlyn Foundation. It explores and understands the lives of young migrants from their own viewpoint.

Sixty in-depth interviews and fifteen testimonies were carried out with young undocumented migrants from Zimbabwe, Brazil, China, Ukraine and Turkey (including Kurdish).

The young migrants five countries of origin capture diverse patterns, objectives and experiences. These highlight how their experiences are shaped and choices are made.

The research was based in three areas, London, North West and the Midlands covering metropolitan, urban and rural areas.

Being undocumented can create a transitory and insecure identity. The youth talk about how it feels to be an 'illegal' in England.

The project explores the themes around lives and livelihoods. This includes experiences of employment; social networks; community involvement; links and obligations with friends and family in their country of origin; and the longer term goals and aspirations.

Community Cohesion in Enfield

The EREC Strategic Race and Equalities Forum (SREF) held a meeting 14th January 2010 at Community House, to consult on the Council's draft Community Cohesion Strategy for Enfield.

The meeting was attended by 25 people, including EREC members, Enfield residents and Black and Minority Ethnic community group representatives.

Mr Ilhan Basharan (Communities Manager) of the London Borough of Enfield was introduced by the EREC Chair, Ade Adeshina. He gave a presentation on the draft community cohesion strategy and explained that the Enfield Strategic Partnership was responsible for developing the strategy in Enfield, why it was needed and who it aimed to reach.

In reply to a question about whether the community cohesion strategy was mandatory, he replied it was not, but it was good practice.

The participants broke into two workshops to examine the question 'What are the key challenges that need to be addressed in order for the aims to become a reality?

The discussion that followed and the workshop recommendations made up the EREC report which was submitted to Enfield Council earlier this year.



Some of the recommendations included:

- ensuring English for Speakers of Other Languages (ESOL) is widely available and affordable, at accessible times and community locations



 educating and campaigning with employers to remind them of their duties under equalities and race legislation in their employment practices and fund groups such as EREC in this respect

Equality Act Guidance Consultation

The Equality and Human Rights Commission (EHRC) is producing statutory Codes of Practice and non-statutory guidance to cover all aspects of the Equality Bill once it becomes law. This will enable people to understand the Equality Act and how it will affect them.

As one of the most significant pieces of equality legislation for many years, it will both simplify and strengthen the law. The Equality Bill will give people more protection from unfair discrimination and should make it easier for employers and companies to understand their responsibilities. There will also be a new standard for public services to treat everyone with dignity and respect.

The EHRC have launched three separate consultations on the three draft guides for employment; services, public functions and associations; and education. The consultation period runs until 16th April 2010 and can be accessed at www.equalityhumanrights.com/equalitybill

Race On The Agenda

In February, Race on the Agenda (ROTA) launched its first report on the impact of serious youth and gang violence on women and girls.

The report looks at:

- the experiences of gang-affected females
- the role of Black and Minority
 Ethnic women's and third sector in responding to this issue and
- the response of statutory policy and decision makers.

The recommendations of the report include targeting more specialist services and policies at women and girls involved in gangs. Policy development and funding across statutory and voluntary sectors should also take account of serious youth violence as a key issue for women and girls.
